4a. CANCELLATION POLICY

Organizer Cancellation:

If the event is canceled by the organizers on or before August 14, 2025, all exhibitor and sponsor payments will be refunded in full within 10 business days of the cancellation announcement.

Exhibitor Cancellation:

Exhibitors who wish to cancel must do so in writing.

- **Before August 14, 2025:** Exhibitor cancellations received by 11:59 PM ET on August 14 will receive a full refund, minus a \$10 administrative fee to cover any processing fees (if applicable).
- **After August 14, 2025:** No refunds will be issued for cancellations received on or after August 15, 2025.

Force Majeure:

In the event of a cancellation or delay due to circumstances beyond the organizer's control (e.g., weather, venue closures, government restrictions), the organizers will work to reschedule the event. If a new date cannot be confirmed within 90 days, refunds will be issued accordingly.
